9 members present and 10 members absent did not constitute a quorum and the December 12, 2006 meeting of the LSUCCC could not be held.

The Chair requested a meeting of the Act 12 Administrative Chapter Study and Development Committee.

The Chair discussed the status of the grant programs along with the requested state funding for code enforcement assistance.

The Chair requested clarification relative to the registration process for Building Code Enforcement Officers (BCEO), and Third-Party Providers (TPP). The LSUCCC Administrator and Legal Counsel provided the requested clarification.

The Chair opened the floor for comments from the audience, and the LSUCCC received comments relative to the LSUCCC registration form, Building Official (BO) duties and certifications, use of copyrighted documents from the International Code Council (ICC), problems associated with the retention of the administrative chapters in the International Mechanical Code (IMC), and the International Fuel Gas Code (IFGC) within the State Uniform Construction Code statute, the inability of "Home Owner Builders" to obtain the services of a TPP, the comparative analysis between the Administrative Chapters of the International Building Code (IBC) and the International Residential Code (IRC), and development of a spreadsheet showing the LSUCCC member attendance records.

The Chair has called a Special meeting to coincide with the Public Comment Hearing Scheduled for December 20, 2006 to conduct a public hearing of the substantive changes to the published rules, and discuss and resolve the issues placed on the agenda for the December 12, 2006 meeting.
