## **Notice and Certification to Hold Virtual Zoom Review Committee Meetings**

The Louisiana State Uniform Construction Code Council (LSUCCC) has scheduled a 2021 IBC/IEBC Review Committee Meeting for the 2021 IBC/IEBC Review Committee on October 25, 2021 at 10:00 AM, to review and consider amendments to the 2021 IBC and 2021 IEBC.

In an effort to mitigate the spread of COVID-19 in Louisiana, and to preserve the health and safety of all members of the public, the Governor has declared the COVID-19 Public Health Emergency and ordered that it is necessary to limit public gatherings in a single place at the same time in an effort to avoid individuals being in close proximity to one another. As a result of the public health emergency, the limitations imposed on public gatherings and personal interactions, and the risks associated with the participation of members in a physical meeting of the LSUCCC, the Administrator of the Louisiana State Uniform Construction Code Council hereby certifies that in order to protect the lives, property, health, safety, and welfare of the citizens of Louisiana, it is necessary to conduct the LSUCCC IBC/IEBC Review Committee meeting October 25, 2021 at 10:00 AM by Virtual Zoom meeting to ensure the presence of a quorum of the review committee members.

Therefore, in accordance with Section 2 of the Governor's Proclamation Number 181 JBE 2021 the LSUCCC will conduct the IBC/IEBC Review Committee meeting by way of Virtual Zoom meeting on October 25, 2021 at 10:00 AM.

The agenda for the 2021 IBC/IEBC Review Committee will be posted as required by law more than 24 hours before the meeting. The 2021 IBC/IEBC Review Committee will utilize a Zoom Meeting and alternate call-in method to conduct the meeting via Zoom.
