The Chair opened the floor for the Legislative Advisory Committee report from Mr. Bobby Byrd. HB165 Status is open pending House Commerce; HB 659 Status is that this bill has not been heard, HB 570 has now been changed to HB 1267 and is pending Senate final passage and it has been moved to the Fire Marshal. HB 470 status has not movement since April 16th consideration. HB 1048 pending consideration on Senate floor.

The committee is going to allow three individuals to receive the Grandfather status; however they have taken test that are required and passed.

New Business:

The chair turned the floor over to Mr. Joiner to comment on bringing jurisdictions into compliance. Compliance jurisdictions have increased to over 93% from the previous number of 89%. Continued effort to reach out to jurisdictions, especially in remote areas, will be continued to bring everyone into compliance.
