NEW BUSINESS:

1. Review and discussion of proposed changes for 2021 IBC Appendix G. (Jackie Dadakis)

Mr. Joiner stated that Appendix G was brought to his attention after attending the House Commerce Committee, to speak to the committee over Freeboard concerns. Mr. Joiner worked with Mr. Nic LeBlanc, Tangipahoa Government, to amend Appendix G. This adoption of the amended Appendix G would benefit the local governments and help address their concerns that the Freeboard amendment effected. Many items in Appendix G is not the purview of the LSUCCC. FEMA is in favor of the LSUCCC adopting the amended Appendix G. The amending and repeals are only addressing Appendix G and does not affect any of the other code amendments. Mr. LeBlanc stated that it was critically important for historical structures and functional dependency use.

A motion was made by Mr. Jake Causey to adopt Appendix G as amended in the documentation provided to the council members. Handout was provided to the members to review prior to the meeting to review the changes. The floor was opened for discussion. The motion was seconded by Mr. Henry Heier. The Chair asked if there were any objections, there were no objections and the motion passed unanimously.

3. Comments from LSUCCC chairman and LSUCCC Administrator.

Mr. Young noted that if the CEA Committee needed to meet then they would be notified and a date would be set in July.
